Federation—Legislative Update—December 1, 2020

Legislative Update

With nine days to go, 2300 bills had been introduced into the General Assembly and about 150 had passed both houses. Between COVID relief, eviction mitigation and police reform, the legislature has had little time to spend on health care, immigration and women's issues, which have been our priority issues.

The paid family medical leave act, The Time to Care Act, was considered a shoo-in to pass this year, has been sitting in committee. It has been put on hold so as not to add to the burdens already placed on businesses during the current economic difficulties. Once passed, this insurance

plan (paid into by both employers and employees) will take two years to implement and become functional.

In 2019, the legislature passed the Prescription Drug Affordability Act to set maximum drug costs to ensure that high cost drugs would be available to all at more reasonable prices. Since then the Governor has not

funded the Board established by the Act. This year the General Assembly funded the Prescription Drug Affordability Board during budget deliberations. It will still take some time for the initial work to be accomplished and implemented.

would provide funding for health care providers to create or expand health services in five poor or rural underserved communities designated as equity zones, has passed both houses and must go to conference committee to work out the differences. This is one of our priorities and will

be a big win if passed and signed by the Governor.

While the COVID pandemic has affected all of us in one way or another, five million women are now out of the workplace and 2.5 million will not get their jobs back. Women also own 10 million small businesses, many of which will not reopen.


Challenges for Women and Families During COVID By CeCe Rund

The Federation once again ZOOM'd in with over 65 participants to hear three talented and informative speakers provide information to help us better understand what has been happening during this pandemic regarding **Challenges for Women and Families During COVID.**



Vinnie DeMarco, President of the Maryland Citizen's Health Initiative, presented information on Equity in Healthcare. He told us that our Affordable Healthcare Act has decreased the uninsured persons from 13% to 4%! There is also an increase in the overall access to healthcare in MD. His organization is working on a trifecta: an easy enrollment program that will ensure that persons get healthcare coverage (House Bill #1002/Senate #893), securing subsidies for the uninsured/low income young adults (House

Bill #780/Senate # 729) and developing a Health Equity Resource Center (House Bill # 172/Senate #463). The committee is looking to increase the state alcohol tax to one cent on the dollar to fund healthcare programs.



Laura Weeldreyer, Executive Director of the Maryland Family Network, addressed *COVID:* Effects on the Family Unit, which runs programs like Head Start, family support centers and a statewide network for childcare. According to Laura, a UNICEF survey revealed that our USA is not a family friendly country in that we severely lack policies to support families and young children. Women remain the "shock absorbers" of all systems and suffer more than men as women have lost more jobs during COVID and are

the only caregiver as child care centers closed during COVID. Women are performing dual roles: caring for kids during the day and holding down some sort of employment in the evenings. Manufacturing and construction jobs, typically held by men, have not been hit as hard during COVID. Children are missing their well-care visits and vaccination visits as mothers rely on clinics but have no transportation or scheduled appointment times. Laura addressed many other issues that women face during this pandemic which will affect the entire family unit. A Maryland Family Network survey showed that 50% of child care providers would not survive this COVID shutdown. The good news is that Maryland will receive a 502 million dollar grant for child care.



Lauren Shaivitz, Executive Director of CHANA, discussed Abuse Issues During COVID. Just as the nation has seen an increase in abuse, so is CHANA observing increases in abuse against women in our Jewish communities during this pandemic. One caller stated, "I don't know if I am more afraid of the virus or my abuser. I could be killed at home, but no one would know due to this lockdown."

There is a new form of abuse that is called, Pandemic Abuse. People feel trapped. Unemployment is up. Alcohol sales have increased by 250% and this leads to more abusive behavior such as spitting on a partner, inviting persons in the home and ignoring

social distancing and face mask wearing. Persons have also gone outside of the home without a mask to intimidate others and their family members or they have attended large and crowded events without taking pandemic precautions. CHANA also sees more elder abuse by either the intimate partner or by children and grandchildren. Elders have issues getting care and food.

There is a lack of resources for abused persons such as court being closed that could have handled cases and lead to help for the abused, inability to seek shelter at a friend's house or with a relative due to COVID and even the closing of hotels that could have housed the abused.

So, what can we do? Support laws and referendums that support abused victims. And, of course, support CHANA when possible with a charitable donation.
