Message from Our President Shulamit Finkelstein



Dear Federation Members, Friends and Officers,

Now that the Passover holiday has ended, I'd like to reflect for a few moments on the culmination of the Exodus story. The culmination was the gift to the Jewish people of the Ten Commandments. These became one of the pillars of not only Jewish law, but also of western civilization. If there was one theme that ran through the diverse speakers and presenters at our meetings this past year, it was how the law affects us as a community, as families, and as women; and furthermore, how we can affect the law.

At our November 2024 general meeting, our guest speaker was Michaela Cohen, Co-Founder of MLAW, the Maryland Legislative Agenda for Women. We learned that for over 30 years MLAW has achieved an amazing record of supporting 119 bills that were passed by the Maryland General Assembly! Many of those bills were enacted to empower women in the areas of health care, domestic violence, employment, and sexual assault. Federation of Jewish Women's Organizations is a member of MLAW and helps to select, develop and advocate for bills of importance to women.

Women's Federation has as one of its core missions to be a voice for its members. For that purpose, we have a Resolutions and Legislative Advocacy Committee. This Committee keeps our members abreast of current legal developments. It also helps us advocate for laws that will improve our lives by preparing resolutions annually for our legislators.

As you know, our keynote speaker for our 109th Convention on May 15th will be Katie Curran O'Malley, Executive Director, Women's Law Center of Maryland. The topic of her address will be "Legal Aspects Affecting the Future of Women." We are very excited that we will be the recipients of important legal information and insights from her keynote address.

Finally, I would be remiss if I did not mention another exciting law-related event sponsored by Women's Federation. On January 23, of this year, we had the pleasure of meeting, via Zoom from Israel, a lovely, soft spoken Israeli mother of six who has been called "the David of her time" and who has been named 5 times by the Jerusalem Post as one of the 50 most influential Jews in the world. Nitsana Darshan-Leitner is the founder and president of Shurat HaDin – Israel Law Center, which is leading the international legal fight to stop terror financing, combat sanctions and boycotts against Israel and to defeat lawfare attacks against the Israel Defense Forces.

In an interview led by Julie Bernstein, Federation Vice President, Ms. Nitsana-Leitner related how she and her cadre of attorneys have secured billions of dollars in judgments against terror organizations, state sponsors of terror and the banks that support them. These judgments have resulted in compensation for the victims of terror. Her goal is to track assets of terror groups and choke off the sources of their funds. We learned the details of how she has filed mega lawsuits against Hamas's financiers, has brought legal actions against the Red Cross, UNRWA, the International Criminal Court, South Africa, Iran, Qatari charities, Harvard University, Al-Jazeera and more, all on behalf of the victims of the October 7th massacre. It was quite amazing to learn how Nitsana Darshan-Leitner is "bankrupting terrorism – one lawsuit at a time."

We hope to continue bringing you informative and exciting speakers and presenters in the upcoming year! Finally, as my dear mother used to say, "I hope you all had a zeesen Pesach" – a sweet Passover!

Federation Legislative Update—2025

Monday was cross over day. That means that any bill in the General Assembly that did not cross over to the other chamber is probably dead for this session.

Three bills which are on the Maryland Legislative Agenda for Women - MLAW -have passed the Senate and now need to pass the House.

First, the Prescription Drug Affordability Act, which authorizes the existing Board to set upper limits on high cost medications for all Marylanders. SB 357 passed the Senate which the House can take up or pass the House bill HB 424. Ask your Delegates to support this bill or the Senate bill, whichever the House takes up.

Second, is the Young Adult Health Insurance Bill, which would extend the current health subsidies, past in 2025. I think the current bill serves young

people up to 25 or 26, Senate Bill 5 passed the Senate and the House can take up that bill or its own Bill HB 297. Again, ask your Delegates to support this Bill.



Third, the bill which we have now supported for several years, SB 631, passed the Senate. The House can take up the Senate bill or pass HB 1198, both of which require the Department of Corrections to move on establishing a Pre Release facility for Women. Last session the money was appropriated for planning, but nothing has been done by DOC since. Ask your Delegates to support passage of either bills.

The last item is to let you know that the State Department of Labor has postponed the start date for Family Leave until 2028. Given the current fiscal situation in Maryland it makes sense.

Our theme was "Bankrupting Terrorism- One Lawsuit at a Time!" with our guest speaker, Nitsana Darshan-Leitner, zooming in from Israel. Nitsana is the founder and President of Shurat HaDin Israel Law Center in Tel Aviv. It is an Israeli based civil rights center which focuses on bringing lawsuits and legal actions on behalf of the victims of terrorism against the organizations and their supporters. As the President of Shurat HaDin, she has represented hundreds of terror organizations and has won hundreds of millions of dollars in compensation on their behalf.

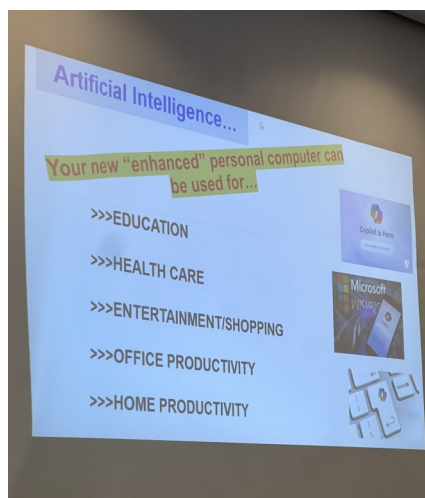
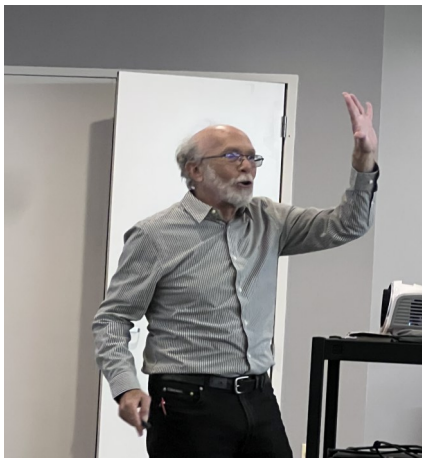
She and her team are handling civil actions against Hamas, Islamic Jihad, the PLO, The Palestinian Authority, Hezbollah, Iran, Syria, Egypt, North Korea, UBS, the Lebanese Canadian Bank and now Qatari enemies. The cases allow the victims of terrorism to fight back. Nitsana is this and so much more. It left us speechless in a great way and fascinated how she does what she does and how it came into being. The question-and-answer period could have been extended for hours. Even through zoom, you could hear a pin drop and could see how focused everyone was in listening.

We felt so fortunate to have her and share her with all of you. Our social action project, being on zoom, was in honor of our Israeli speaker, which was to give back to an organization of your choice in support of Israel in its quest for peace and to successfully free all hostages.
