## **Message from Our President**



As I am writing this message, 2020 is around the corner. A new decade in the secular calendar is beginning and for me, this is the time to reflect on the past and think about long-term planning.

Federation is celebrating its 104th year and remains the only women's federation in the country. With pride, we have always been attuned to what is going on in the community and have responded to the changes around us. The ability to adapt and respond is what keeps this organization a vibrant entity.

As the year begins, we focus our attention on the country's upswing in anti-Semitism and the denial of the Holocaust experience. To combat this scourge, Federation and the Baltimore Jewish Council will present a program on Holocaust education. A panel will address how the Maryland State Department of Education will implement this new curriculum on Holocaust education in the public schools and how we can help to facilitate this in our local schools. This program will also have a review of resources in the community and take a broader look nationally on what is being done in the area of Holocaust education programming. Join us on Thursday, January 23rd at Beth Israel Congregation. We thank the Sisterhood for hosting this event.

I often peruse the Federation's website, and sometimes I like to look at the summary of our history. What I see is that each decade has presented new challenges, and the women leaders of our Federation have educated our members on issues, provided resources and developed strategies to solve problems. Members have advocated on important women's issues. The women of Federation were involved in the suffrage movement back in 1918 and this year, 2020, we celebrate the

100th year anniversary of women getting the right to vote.

As we enter 2020, there is an awareness among us of some of the challenges facing the Jewish community and women's groups. There have been changes in how Jewish life is structured for many people and changes in family dynamics. Many established Jewish organizations have to examine their missions and how to stay relevant.

There are the other challenges, such as the rise of anti- Semitism, how divided our Jewish community has become on Israel and many other issues. That is why Federation is so important. We need to hear all the voices of our women. We represent a broad spectrum of orthodox, conservative and reform groups and many service groups, as well as the women who are part of the national Zionist organizations. We hope to continue the needed conversations over the next year and beyond on these and other relevant issues. Federation will continue to get speakers and sponsor programs that help educate us, as well as have action plans to make a difference when we can.

One issue Federation decided to address this year is how to help combat anti-Semitism. Education is the key to understanding how the Holocaust could have happened and how to prevent other genocides from happening. This must be part of the way we try to combat anti-Semitism. Recent studies show that many people have very little knowledge of what really happened during the Holocaust and what lead to this atrocity. As anti-Semitism rises in the US, the importance of understanding what happened during the Holocaust is essential. Federation is partnering with the Baltimore Jewish Council which provides many resources for the community on Holocaust education and helps advocate to have increased Holocaust education in the public schools.

Federation's Mid-Winter Conference, hosted generously by Beth Israel Sisterhood and co-sponsored by the Baltimore Jewish Council, is a very important program. Many are aware of the recent rise in anti-Semitic acts and other hate crimes in the U.S. It is imperative to be educated about the Holocaust and what led up to it in order to prevent this from happening again. Therefore, Federation will sponsor a panel presentation on Holocaust Education in Schools featuring a representative from the Maryland State Department of Education (MSDE) and two representatives from the Holocaust Remembrance Commission.

Recently the (MSDE) issued an announcement that they would be enhancing the curriculum of Holocaust Education in Public Schools through the social studies department. Dr. Salmon, State Superintendent, announced the changes in response to concerns about Maryland's Holocaust education requirements raised earlier this year by members of the General Assembly, the Baltimore Jewish Council and the Jewish Community Relations Council of Greater Washington.

Bruce Lesh, Director of Social Studies, Science, STEM, Environmental Literacy, and Disciplinary Literacy, will represent MSDE and discuss how this program will be implemented throughout the state. Rachel Glaser and Margie Simon from the Baltimore Jewish Council Holocaust Commission will discuss the resources on Holocaust education available to all community members and why it is so important that Holocaust education is implemented. The moderator of our discussion will be Jo-Ann Orlinsky.

# Future and Challenges of Policing on September 19, 2019

We welcomed over 60 persons from 19 organizations to our 2019 opening breakfast meeting held at North Oaks in Pikesville on September 19th. Our featured speaker was Chief Melissa Hyatt, Baltimore County Police Chief. Chief Hyatt provided us with insight into becoming the first woman to hold this position. Chief Hyatt also spent time with us describing what the Baltimore County Police are currently doing to protect our neighborhoods and how she sees the future of our Baltimore County Police Department, as well as describing challenges of policing. Chief Hyatt graciously opened the session for questions and answers. The Federation sent in a donation to the Baltimore County Police Department Fund in her honor.











#### Dinner program on November 7, 2019

On November 7, 2019, over 70 ladies arrived at Har Sinai-Oheb Shalom Congregation on Park Heights Avenue to enjoy a lovely dinner catered by Market Maven and to hear a special presentation regarding fake news. Fake News: Separating Fact from Fiction was presented by Joyce Garczynski, Communications & Development Librarian at Towson University's Albert S. Cook Library.

Joyce Garczynski, our speaker, said: "In a world where information flies at the speed of social media and opinions masquerade as evidence, how can someone separate fact from fiction? It is most difficult to do. A recent multinational survey found that almost 60% of respondents said that they have a difficult time determining whether news was true or not true." She took us through the history of misinformation by providing examples of fascinating, historical fake news from famous persons. She then explained some of the efforts to stop the spread of this fake news, but also reminded us that once a story is out, it can be believed regardless of proof to the contrary. Fake news is misinformation. Joyce provided us with some advice as to how we can check on news stories as we need to do our own research to discover the real news and truth.

The Federation also welcomed Rachel Katzenberg, who is working toward her Girl Scout Gold Award. She is working with an organization called Days for Girls that are assembling personal hygienic packs for impoverished women in Thailand. This worthy cause helps hundreds of women to care for their personal needs and enables them to stay active within their community. # Federation—Legislative Update—August 2, 2019

remains to be seen how the committees will look in their final configurations. It is, however, a

boost to the Baltimore region to have both leaders familiar with the region's assets and problems.

As we look forward to the January 8th opening of the 2020 session of the legislature, we look back at legislation which did not pass last year which we will continue to support in conjunction with the Maryland Legislative Agenda for Women MLAW) and other coalition organizations.

The Family and Medical Leave Insurance Program, would set up an insurance fund to provide partial wage replacement for employees who take leave to care for a new child, a family member with a serious health condition, their own medical condition or a family member's military deployment. (Paid Family Leave). Only 17% of U.S. employees have access to unpaid leave under the Federal Family Leave Act. Legislation passed in 2018 in Maryland provides state employees with a parental leave benefit. A portion of wage replacement would be drawn from a fund pool into which employees and employers contribute, based on the employee's wages. In Maryland, 79% of

mothers are in the workplace. Nearly 25% of women take ten or fewer days of parental leave, potentially putting themselves and their children at risk.

Expansion of Maryland's Vacatur Law for Survivors of Human Trafficking. Maryland law already permits survivors of Human Trafficking to vacate, or set aside, convictions for prostitution as forced by their human traffickers. However, they are still subject to serving sentences for other convictions arising from their being trafficked, such as trespassing, stealing or drug possession. This bill would expand Maryland's current vacating convictions law to apply explicitly to survivors of human trafficking. Ninety-one percent of survivors have nine or more different arrests. Their criminal records prevent them from getting jobs or finding housing which traps them in poverty.

Family Law- Marriage -Age Requirements. Currently in Maryland, the age at which a young person can be married is 15. Maryland has the lowest age floor in our surrounding states. This is the fifth year this bill is being introduced. This bill would raise the age to 17, although 18 is preferred. It would also provide judicial oversight. Between 2000 and 2017, 3400 minors were married in Maryland. It puts young women in a place to be susceptible to verbal and physical abuse. In addition, minors can't file for divorce until they are 18.

We will keep you up-to-date on these and other items as the session progresses.
