

# Message from Our President CeCe Rund



We said goodbye to a beautiful fall and hello to a fast-incoming winter. By the time you read this, Chanukah will have occurred. I sincerely hope that you were able to see some new light during these dark times of war and suffering. We have a continued

hope of peace for our people, for Israel and, certainly, for this world!

A new secular year is here, and The Federation is ready. When I took office as President of The Federation, we were coming off the COVID shut down. I discovered that it takes a year to reorganize and organize again, and we are doing this with vigor. So, what's happening within The Federation? Julie Bernstein was appointed as our Representative Liaison and has been working with our constituent organization representatives to strengthen our bonds and better understand your needs. We met one of those requested needs by sponsoring a President-Representative Forum last year and had Annette Saxon and her panel present on how to promote our organizations. Another project that I am doing is highlighting individual member organizations in our Flame and on our web site. The Executive Board voted to continue to provide a yearly updated Directory to all members and Friends. The Board also voted to keep the cost of our very reasonable dues at \$50 per member organization.

I began working on a March trip to Annapolis to meet with our legislators over lunch and to observe our legislators at work. However, due to major ongoing construction within the government complex, this trip must be postponed to 2025. At present, we keep an eye on women's legislative issues through MLAW and have representatives attending the MLAW meetings.

The Federation is also initiating a Lilith Salon. The first Salon was held at the home of Helene Waranch on December 3rd at 3 pm. The only prerequisite is that you subscribe to Lilith Magazine as the salons discuss various articles within each edition.

# Federation Legislative Update—2023

Attorney General, Anthony Brown, Suspends CAIR rising in resistance, and called babies that were Director From the Hate Crimes Commission Source: murdered in the Hamas attack on Israel as "Forty Fake December 1, 2023. Jewish Times Israeli Babies."

Zainab Chaudry, Director of the Maryland Office of the Council on American-Islamic Relations (CAIR), has been suspended from the Maryland Commission on Hate Crimes, Response and Prevention. Many social media posts by Chaudry compared the Israeli government to the Nazis.

She also described actions by Hamas as freedom fighters

Attorney General Brown said in a statement: "The commission is facing its first test. How we respond has deep implications. I take this very seriously and I will do everything possible to bring people together to move forward the critical work of this commission".

#### Maryland Legislative Agenda for Women (MLAW) Updates

**Legislative Update**

All of the following bills passed (more bills listed under the MLAW 2003 Legislative Agenda Final Report).

These are four of the seven bills listed on the website:

#### (HB705/SB798) Declaration of Rights-Rights to Reproductive Freedom

Ensures the right to reproductive freedom in our Maryland Constitution including decisions related to preventing, continuing or terminating a pregnancy.

#### (HB808/SB589) Reproductive Health Protection Act

Protection for pregnant individuals seeking abortion care as well as health care providers, support organizations and volunteers from civil, criminal and administrative liability.

#### (HB4/SB129) Criminal Law-Sexual Crimes-Repeal of Spousal Defense

Repeals the current statue that makes marriage a defense to some sex crimes. Marriage will no longer be a defense against rape or sexual crimes.

# (HB297/SB292) Criminal Law-Victims of Child Sex Trafficking and Human Trafficking-Safe Harbor and Service Response

Provides a safe harbor for child victims of sex trafficking and prevents prosecution for acts committed as a result of their trafficking, including prostitution and other related offenses. Prevents criminalization of children and divert youth into services (now available statewide).

In 2009, CHANA expanded it's mission to provide victims and survivors of childhood abuse with trauma informed, community oriented and mental health services. In 2013, CHANA initiated its elder abuse program. CHANA offers a Jewish response to the needs of people who experience abuse in Northwest Baltimore City and County. CHANA provides crisis intervention, education and consultation and advocates for community awareness. Services include trauma informed supportive counseling, crisis intervention, legal advocacy, shelter, support groups and prevention education. —"Everyone deserves to feel safe." HADASSAH—An international organization, Hadassah focuses on advancing health care and medicine, connecting to Israel and Zionism and advocating for change. 


# November Dinner Meeting with Dr. Dan Morhaim


